### Price:

- ✓ All fundraising merchandise is to be sold at the price as advised by IDFA
- ✓ Prices quoted are in Australian Dollars (\$AUD)

### Methods of Payment:

- ✓ *If you wish to purchase our merchandise **Upfront**, you may pay by:*

1. Credit Card (MasterCard or Visa)
2. Direct Deposit
3. Cheque
4. Cash

- For merchandise orders paid in advance we will deliver to a street address only. Anticipated initial delivery for orders is within 3 - 5 business days after your order is received.
